For longtime Karmanos Cancer Institute donor Kathleen Levillier, supporting cancer research is about being part of a *TEAM*.

"Karmanos is engaged in *Timely* research, they have *Expertise*, they have *Access* to labs," she says. "*Money* is the other component, which is my small part. People often think you have to be a millionaire to make a meaningful gift, but small gifts can also accomplish big and important things."

Kathleen, a retired salesperson for the Gillette Razor Company, has given generously to Karmanos for the past 40 years. After retiring, she became a certified tax professional and learned about the benefits of donating IRA assets to charity. She said a qualified charitable distribution from a Traditional IRA is a tax-wise way to manage retirement income.

"If you are over age 70½, you can write a check from your IRA directly to Karmanos or another charity of your choice," Kathleen says. "There are no federal taxes on donations of up to \$100,000 per year, and you can use that donation as part of your required minimum distribution from your IRA (in the year you turn 72.)"

"I've made qualified charitable distributions for the past three years and plan to do this in the future. I've donated to Karmanos and other charities I care about while saving money on my taxes."

As a breast cancer survivor who received treatment at Karmanos, Kathleen is deeply passionate about the care we provide to patients.

"In January 2014, I was diagnosed with four kinds of breast cancer with lymph node involvement," she says. "After having a partial and then a full mastectomy, I went to Karmanos. Dr. Lawrence Flaherty developed my treatment plan, which included chemotherapy."

"I made more than 70 visits to Karmanos for treatment. I was a little scared before going to the infusion center for the first time. I thought everyone would look sad and sick. I was wrong. Most patients were smiling and happy. Volunteers brought us warm blankets and sandwiches. The nursing assistants were especially kind."

Today, Kathleen is cancer-free. She returns to Karmanos regularly for checkups.

"Dr. Flaherty is the best," Kathleen says. "He explains things in easily understandable ways. From my first appointment, he exuded a quiet confidence that I was going to be okay."

Kathleen's first husband also received treatment at Karmanos for lung cancer. She credits Karmanos with helping him survive an additional 28 years. Her mother-in-law and second husband also received treatment at Karmanos.

"My mother-in-law believed the doctors at Karmanos were the best she ever had," Kathleen says. "My second husband died five months after receiving a pancreatic cancer diagnosis. We trusted our Karmanos physicians completely, even when his prognosis wasn't good."

Kathleen designated her most recent gifts to Karmanos to support cancer research. Her gifts are in honor of the doctors, nurses and staff who treated her.

"Karmanos doctors are elite cancer specialists," she says. "The kindness and professionalism of the staff – from the parking lot attendants to the doctors, techs, nurses, receptionists, schedulers and nurses – shows in everything they do."

Making a difference doesn't always have to come in the form of cash or a check.

- Stock or appreciated assets
- Donor advised fund
- Host a fundraiser
- IRA distribution

WHAT ARE THE ADVANTAGES OF GIVING TODAY?

These choices may provide tax advantages depending on the type of gift you make. If you take the standard deduction, you can deduct up to \$300 for cash gifts (\$600 for married couples filing jointly) to qualified charities such as Karmanos Cancer Institute. If you itemize your taxes, you can make a cash gift and receive an income tax charitable deduction for its full value up to 100% (instead of the previous 60%) of your adjusted gross income. These tax incentives are only available for cash gifts made in 2021 and do not apply to donor advised funds or supporting organizations.

In the case of appreciated assets and property, you eliminate capital gains taxes if you've owned the assets for more than one year. If you are $70\frac{1}{2}$ or older, you can make a tax-free gift directly from your IRA.
